Weather Protection

RAIN OR WET COURTS	EXTREME HEAT
When Gyration closes courts because the playing surface is unsafe, eligible reservations receive a court credit or complimentary rescheduling option.	Management may restrict or close play when heat conditions are unsafe. Affected eligible reservations receive a court credit or rescheduling option.
AIR QUALITY	HIGH WINDS OR OTHER CONDITIONS
If outdoor activity is considered unsafe and courts are closed, affected eligible reservations receive a court credit or rescheduling option.	Outdoor play may be suspended whenever weather or other conditions create an unsafe playing environment.

GYRATION WEATHER GUARANTEE
If Gyration Fitness Center closes outdoor courts because of unsafe weather or court conditions, eligible reservations receive a court credit or rescheduling option. Weather credits apply when facility management determines that courts are not safe for play.

Important pricing notes

Rates are per court, per hour. Membership rates require an active membership in good standing. Prime-time windows may be adjusted seasonally. Tournaments, leagues, clinics, events, and private bookings may carry separate rates. Court credits, rescheduling, expiration, late cancellation, no-show rules, and operating policies are subject to the final membership agreement and published reservation policies.
